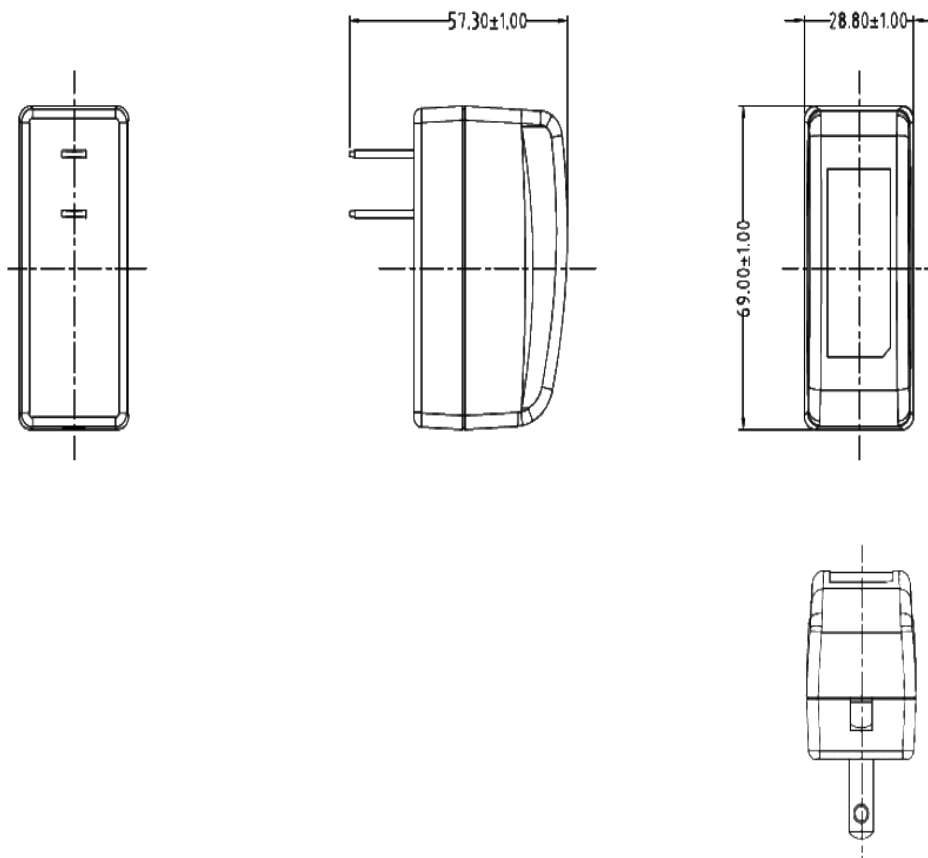

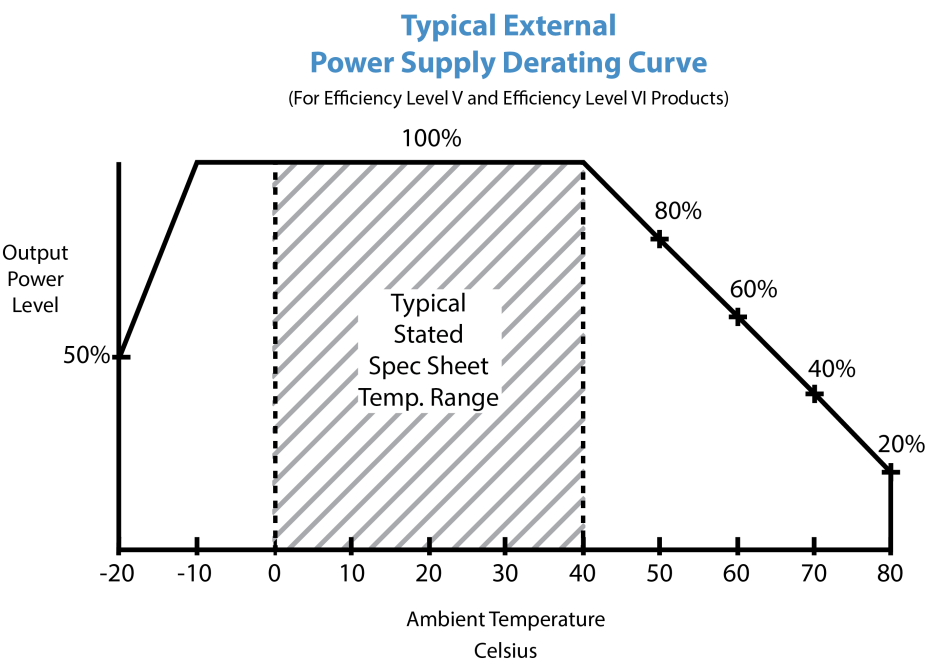

DERATING CURVE

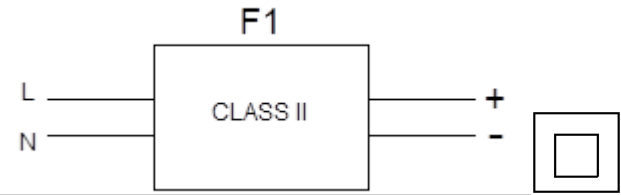

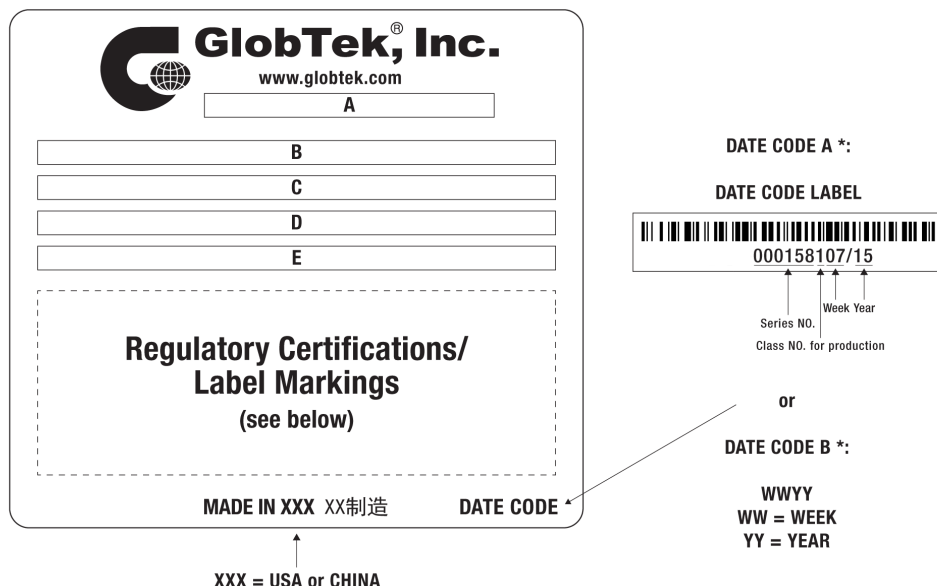

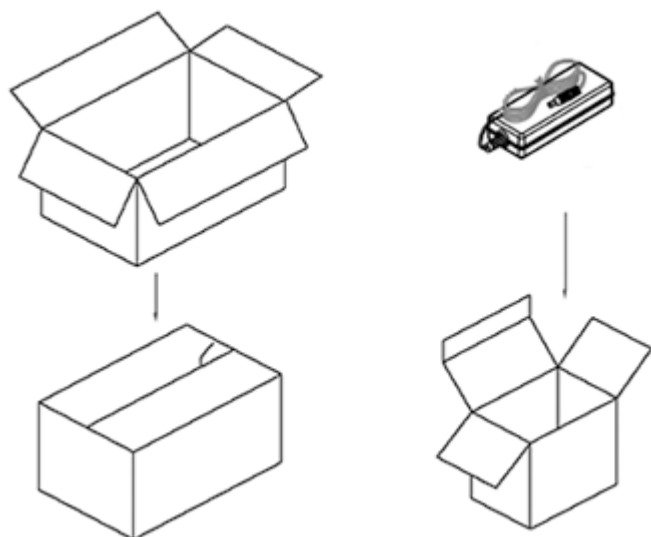
