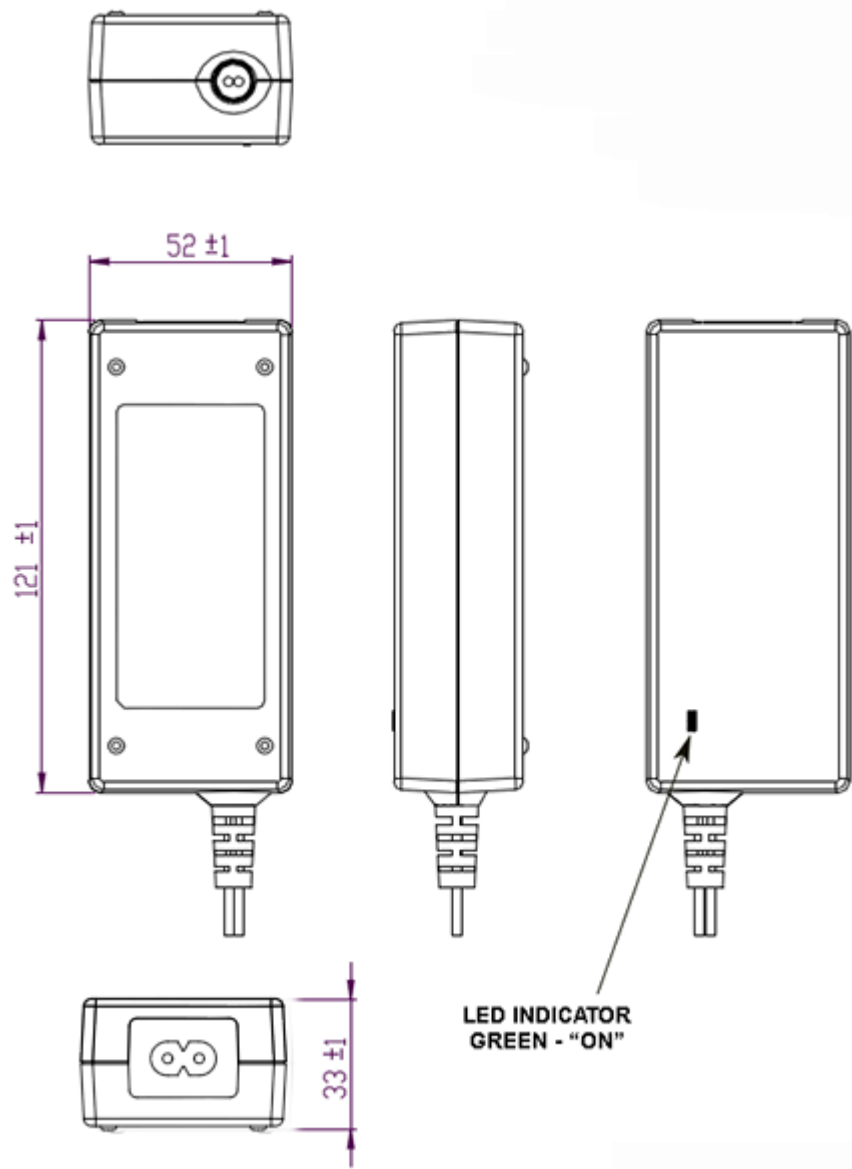

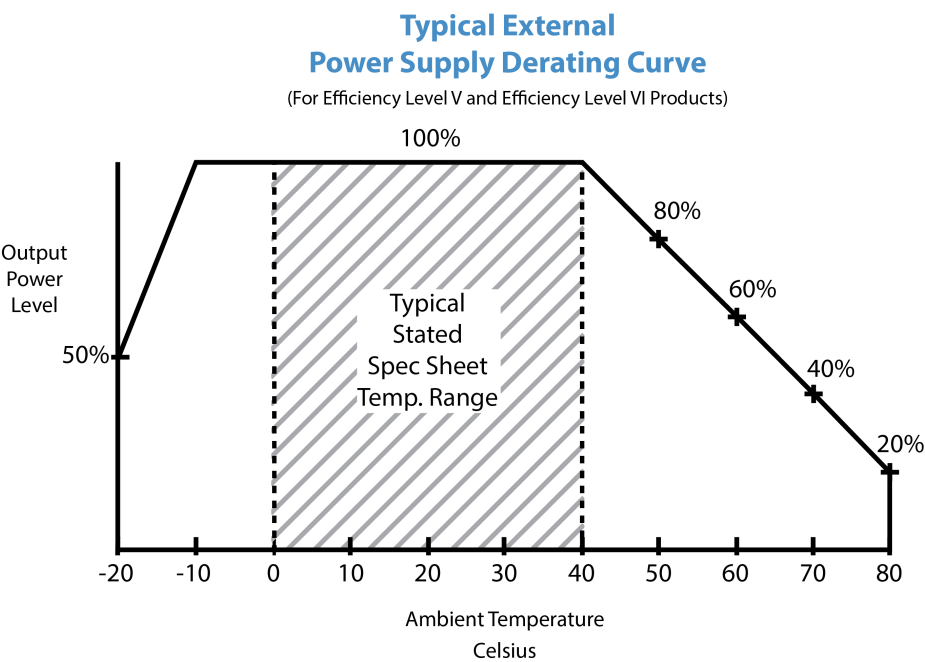

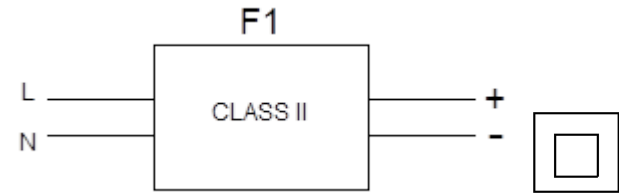
DERATING CURVE

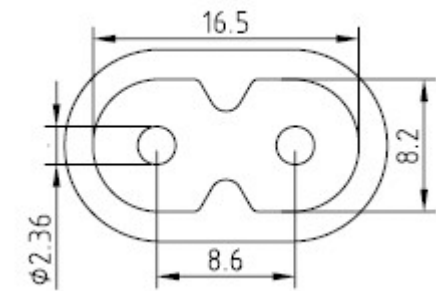
