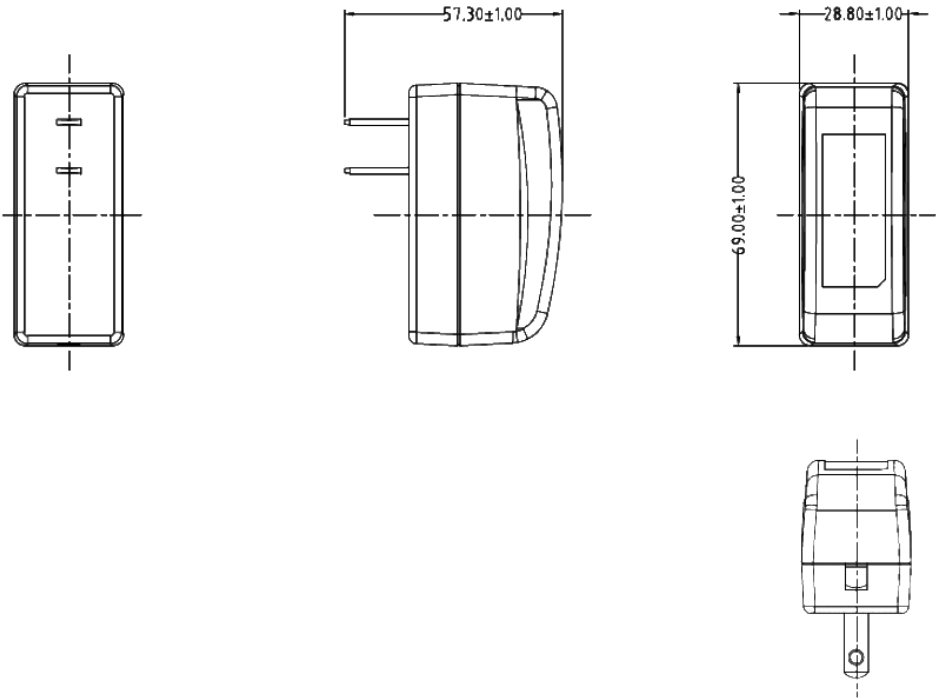

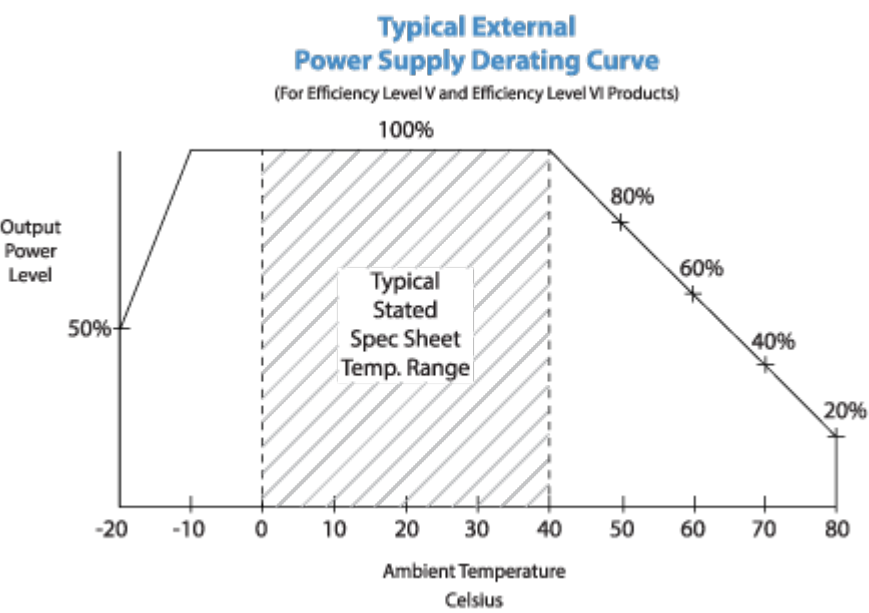

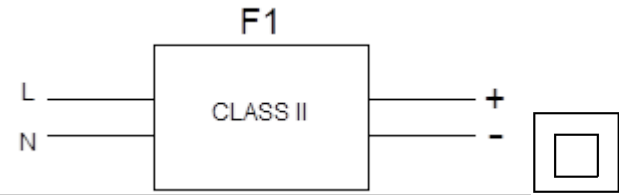
DERATING CURVE

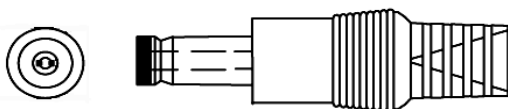

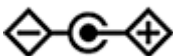

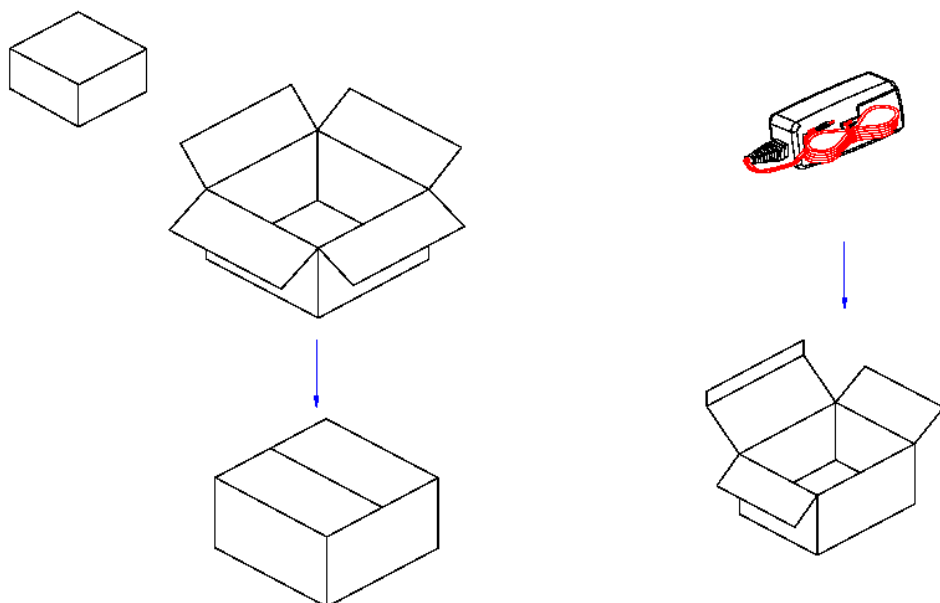
