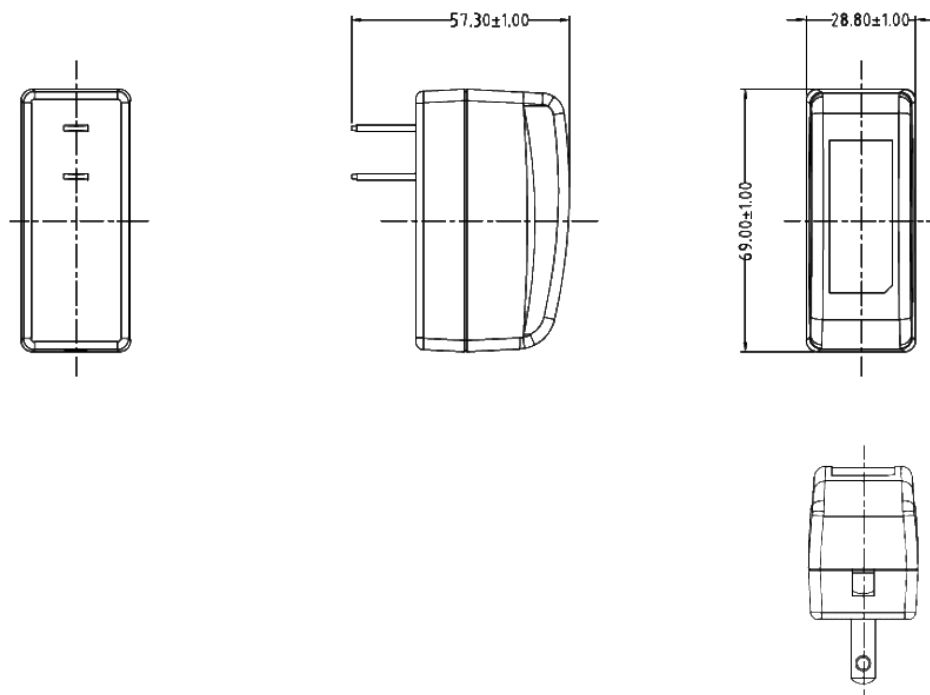

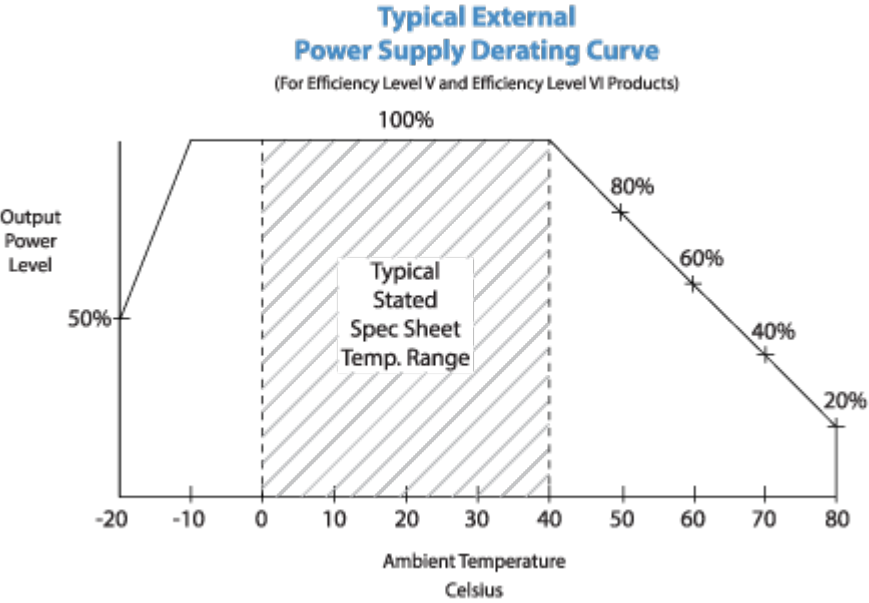

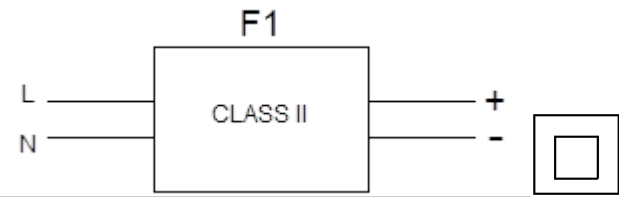
DERATING CURVE
