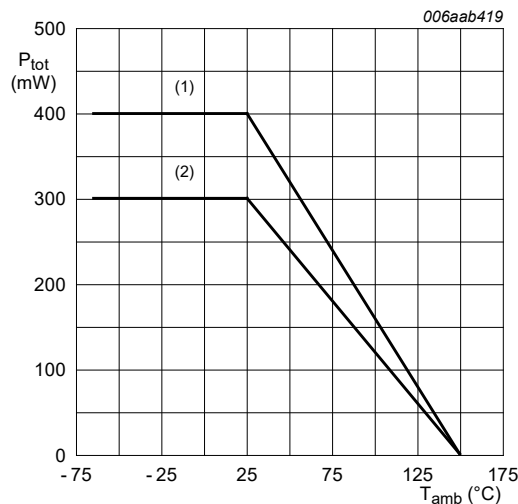

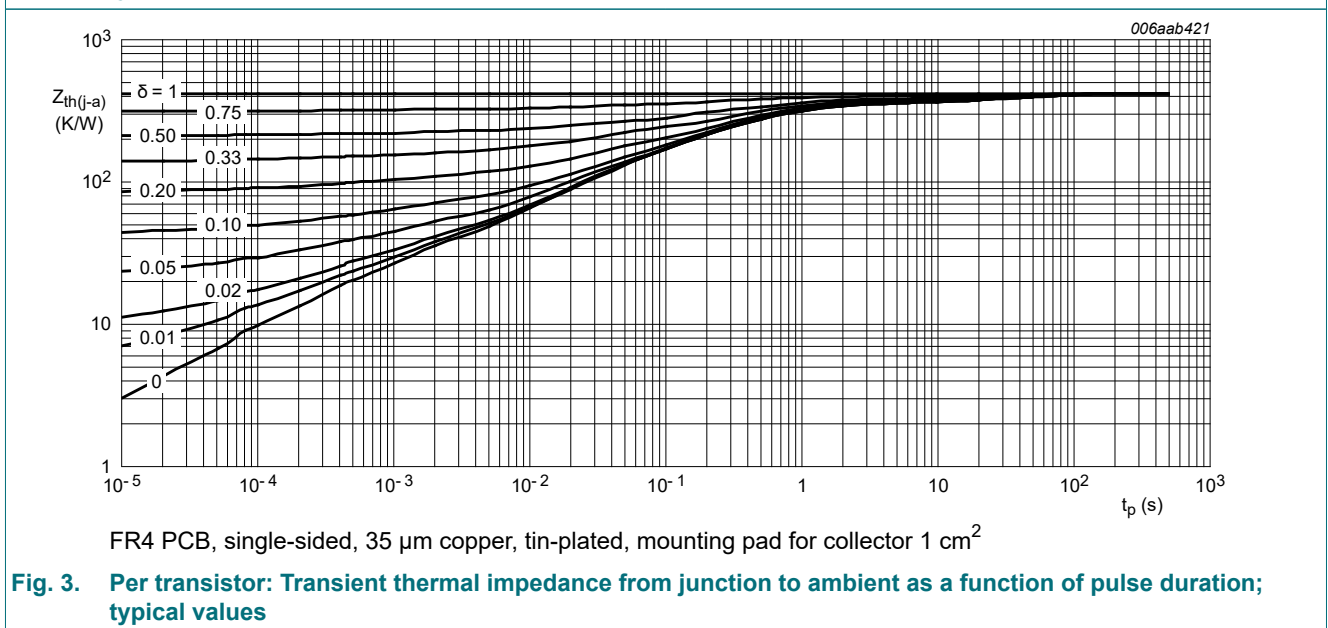
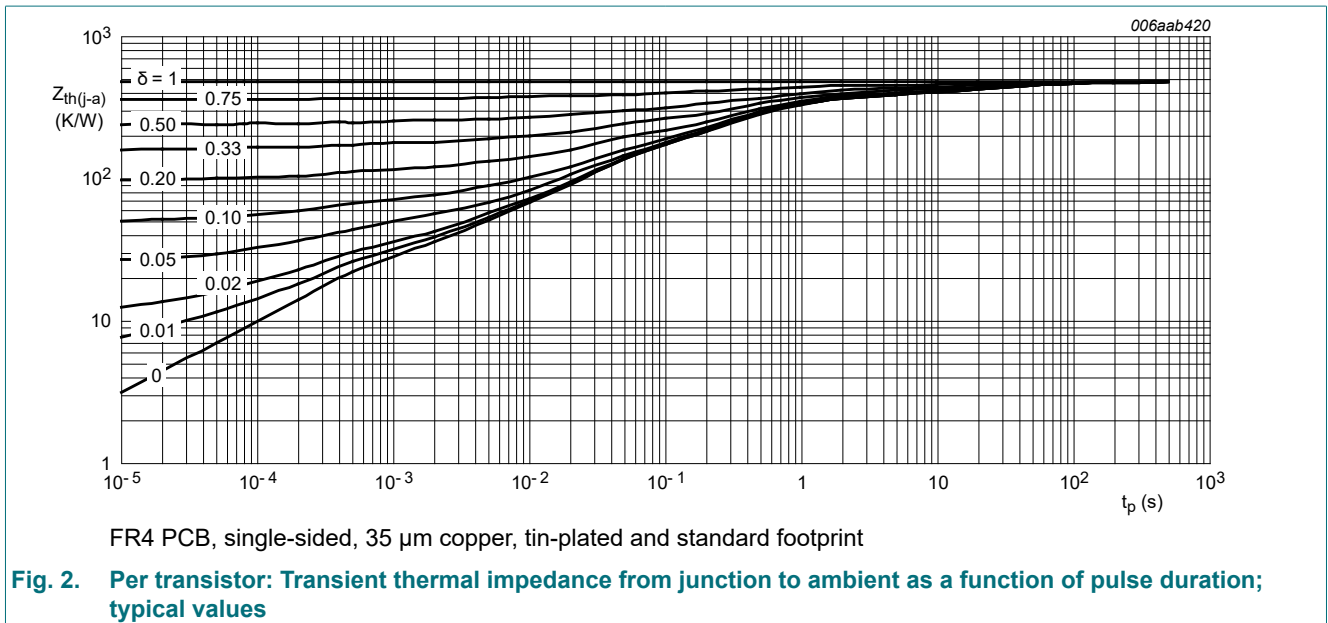
Fig. 1. Per device: Power derating curves SOT363 (SC-88)

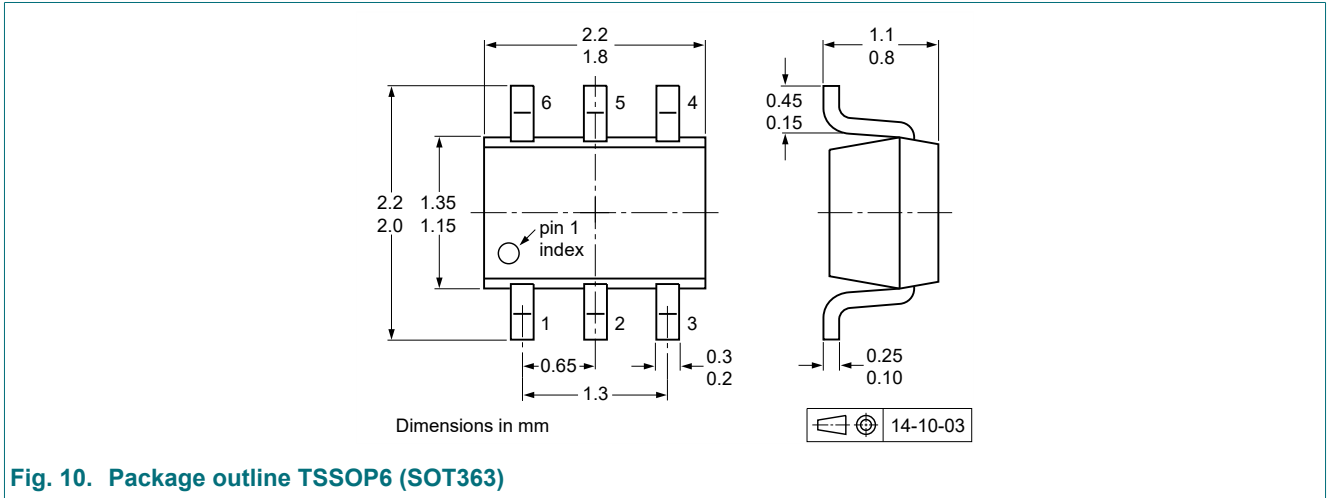

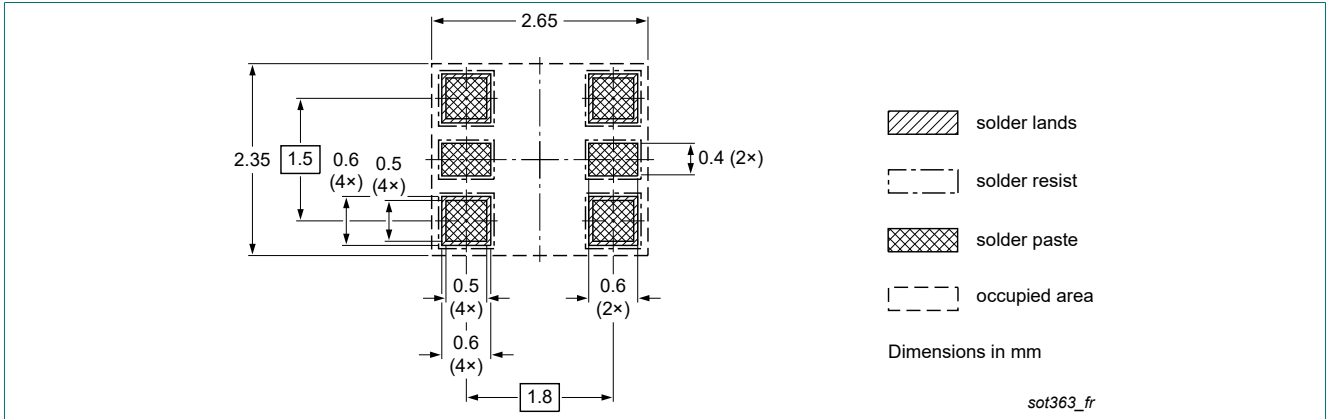


Fig. 11. Reflow soldering footprint for TSSOP6 (SOT363)

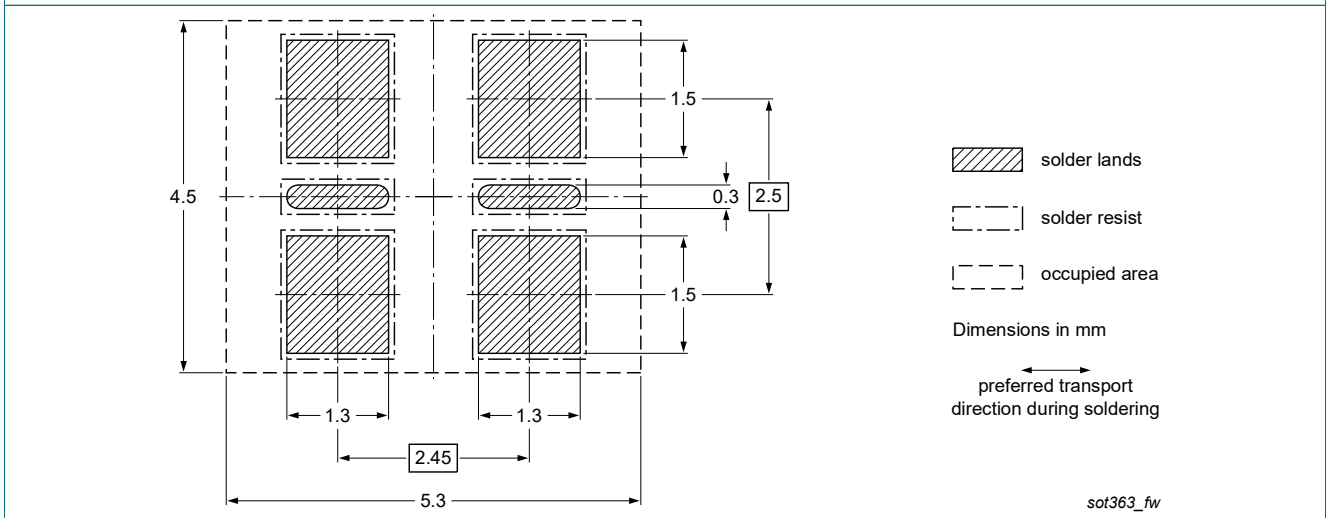


Fig. 12. Wave soldering footprint for TSSOP6 (SOT363)
