




Relative Spectral Emission⁶⁾




Radiation Characteristics⁶⁾









Relative Luminous Intensity ^{6), 7)}









Relative Luminous Intensity⁶⁾






Max. Permissible Forward Current


Permissible Pulse Handling Capability

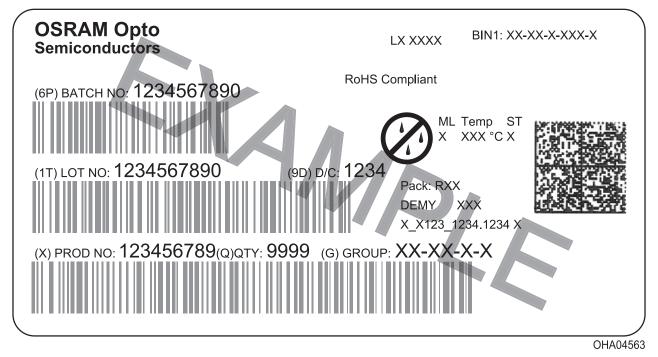
