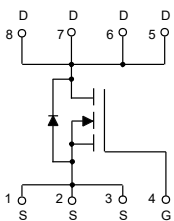

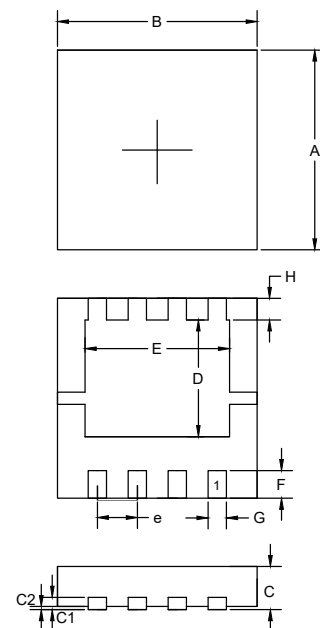

Fig. 1 - Typical Output Characteristics

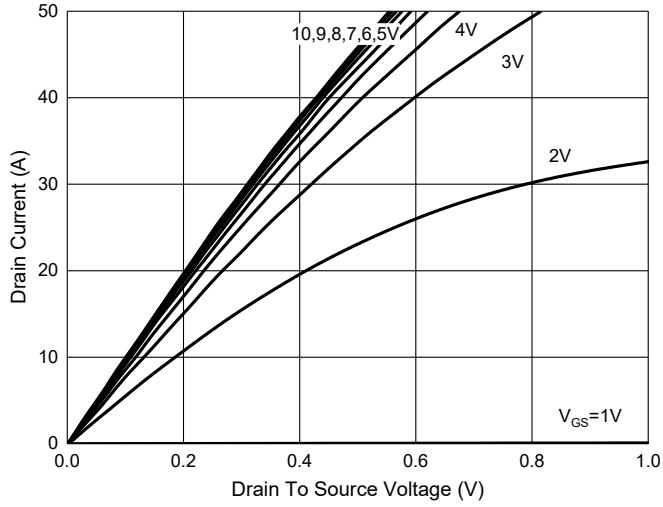


Fig. 2 - I_S—V_{SD}

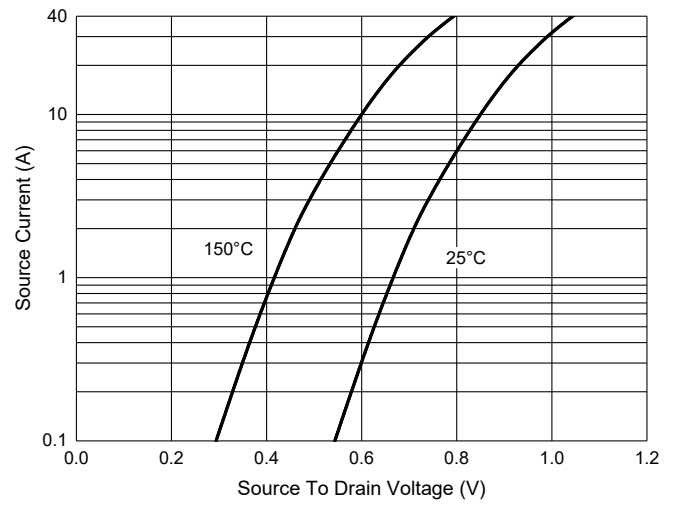


Fig. 3 - R_{DS(ON)}—I_D

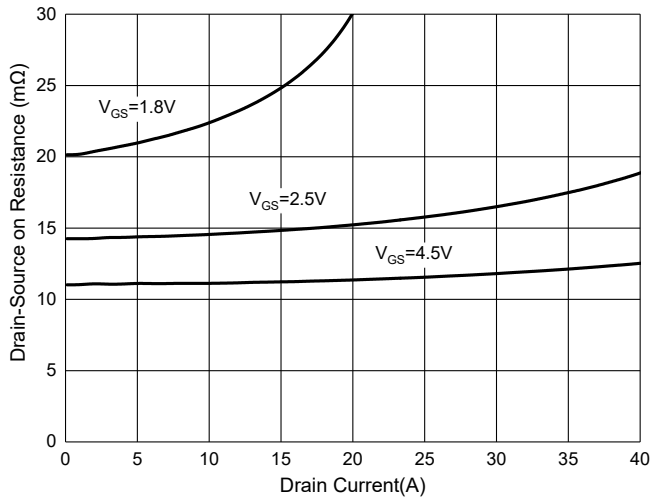


Fig. 4 - Normalized On Resistance Characteristics

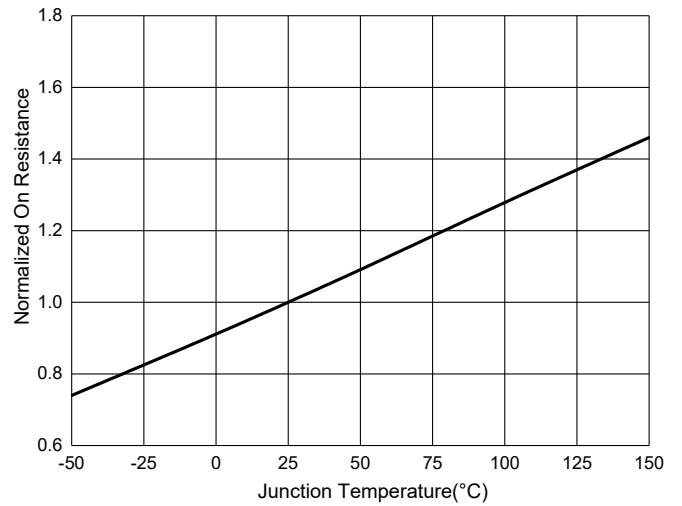


Fig. 5 - Capacitance Characteristics

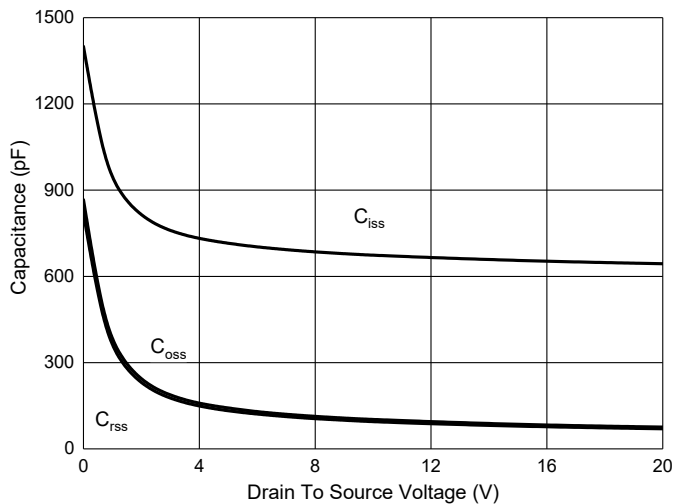
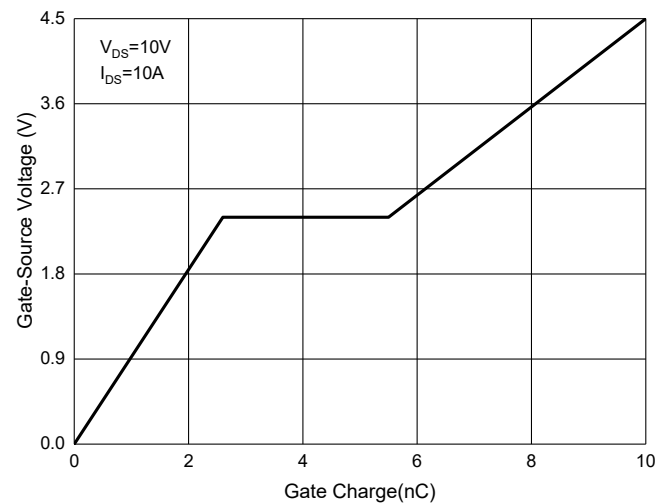
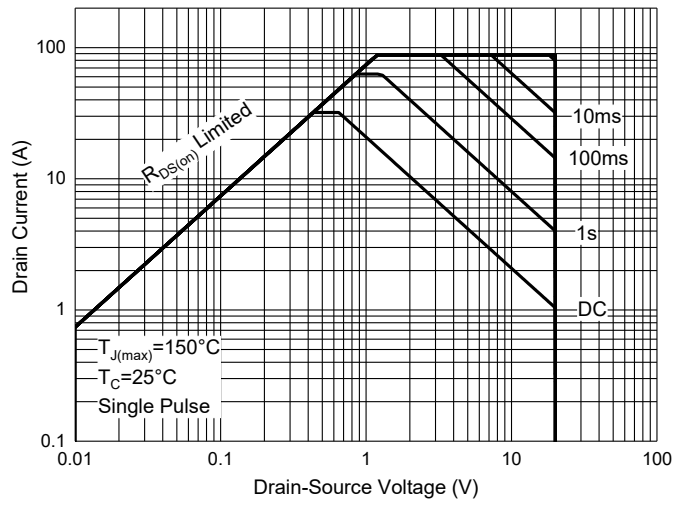


Fig. 6 - Gate Charge
