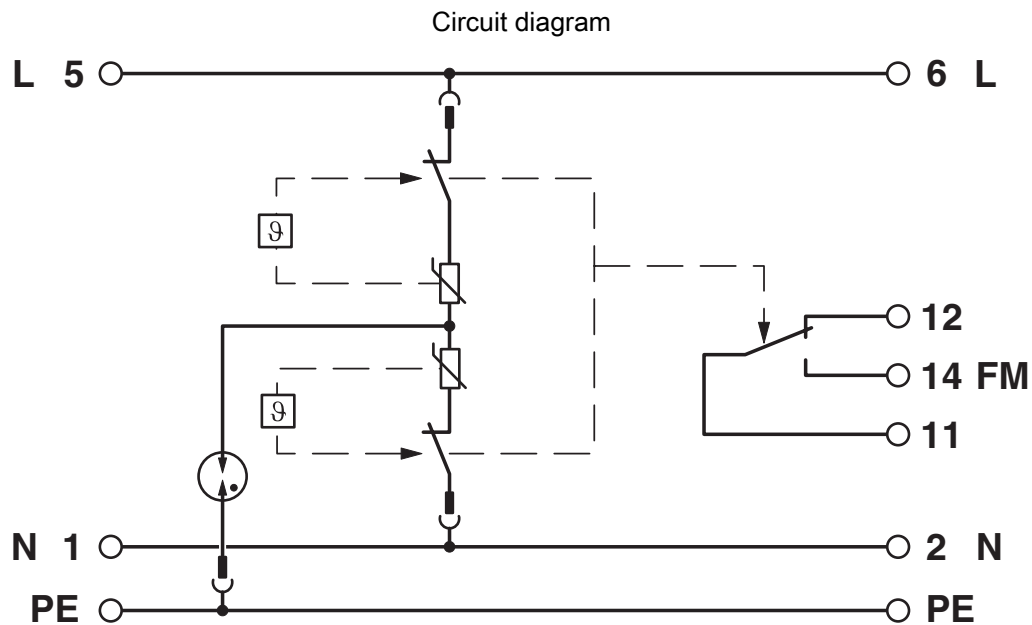
Nominal current depending on ambient temperature

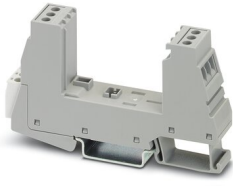
