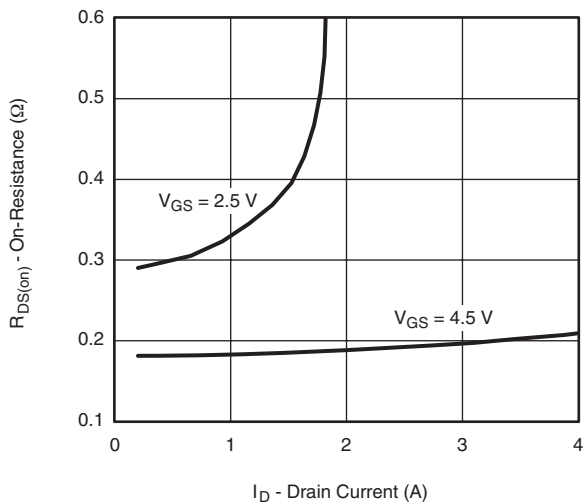

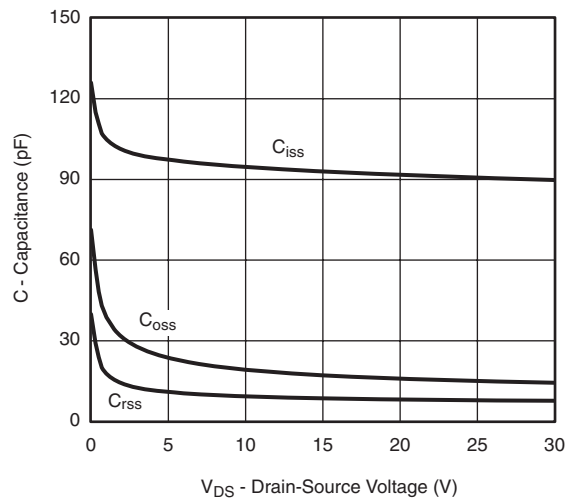

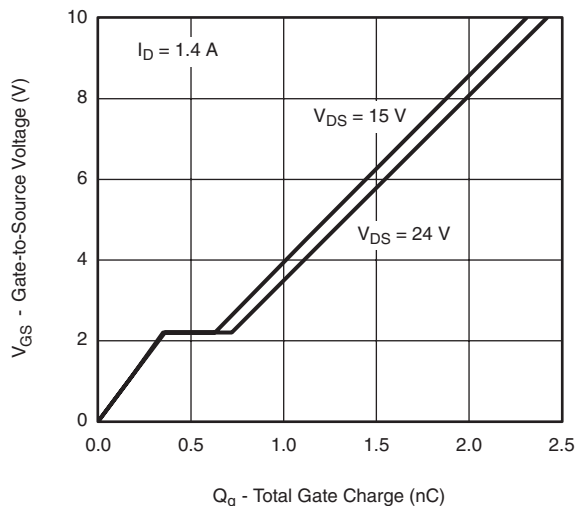
Transfer Characteristics



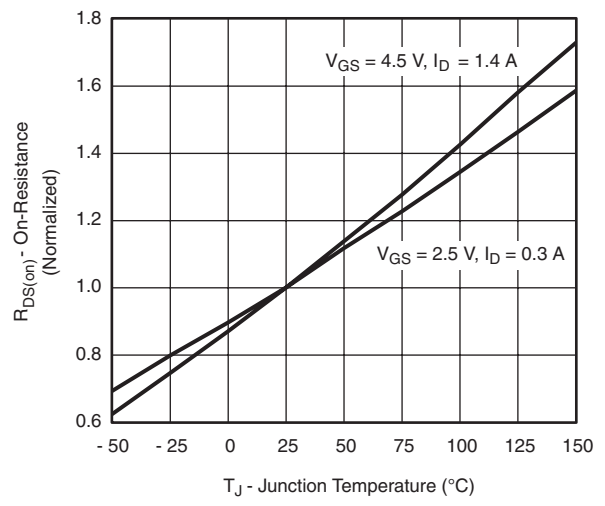
On-Resistance vs. Drain Current



Capacitance

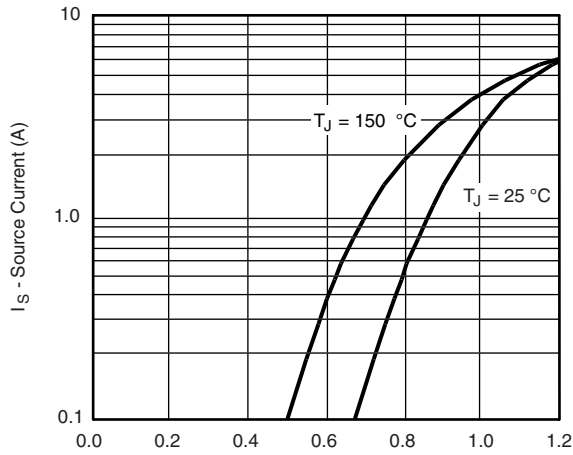


Gate Charge

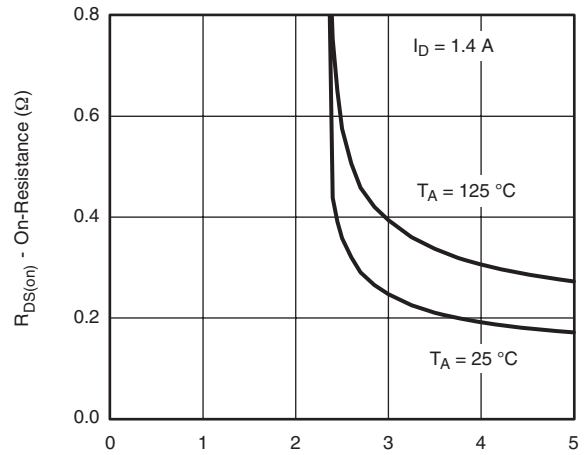


On-Resistance vs. Junction Temperature

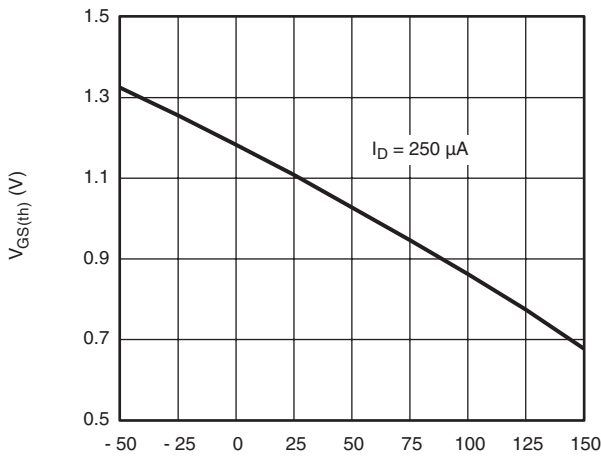

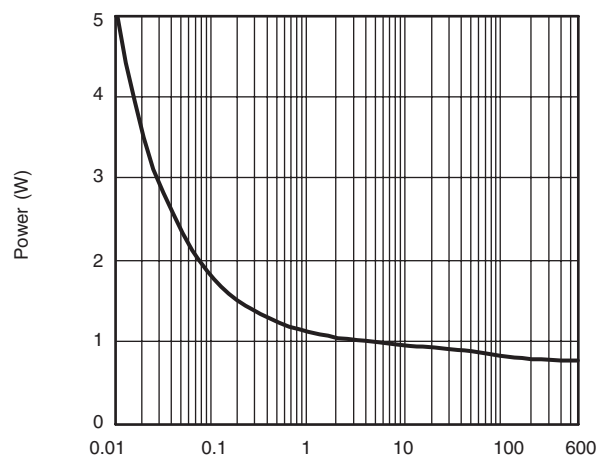
V_{SD} - Source-to-Drain Voltage (V)
Forward Diode Voltage



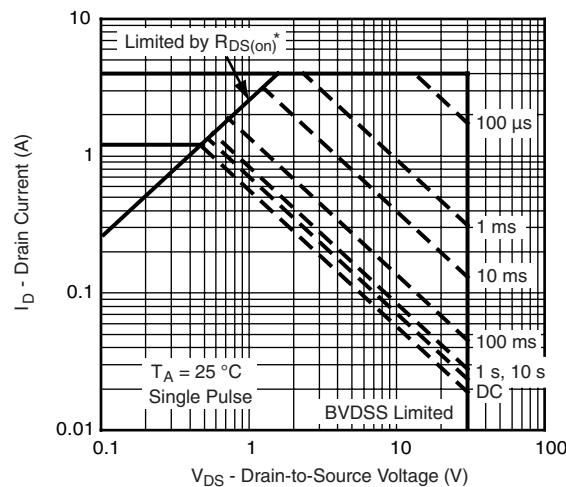
V_{GS} - Gate-to-Source Voltage (V)

Threshold Voltage



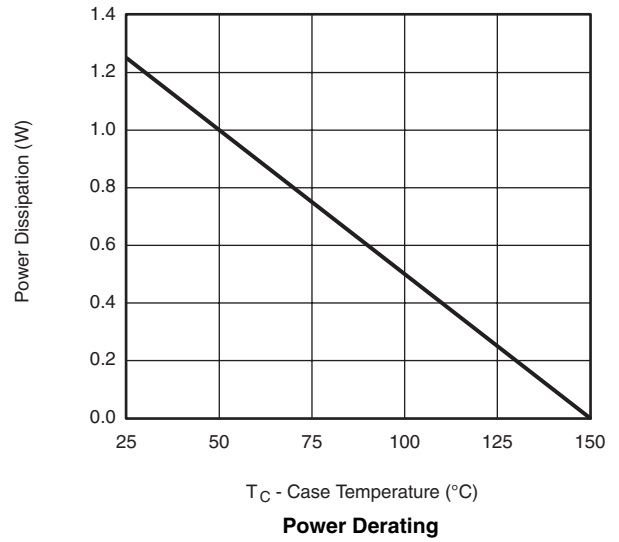
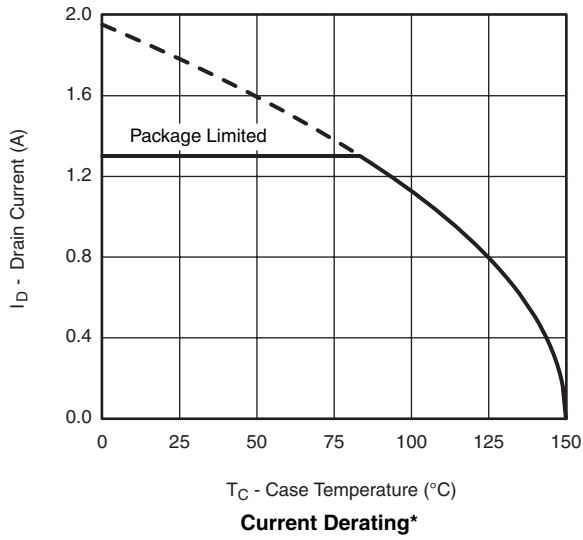

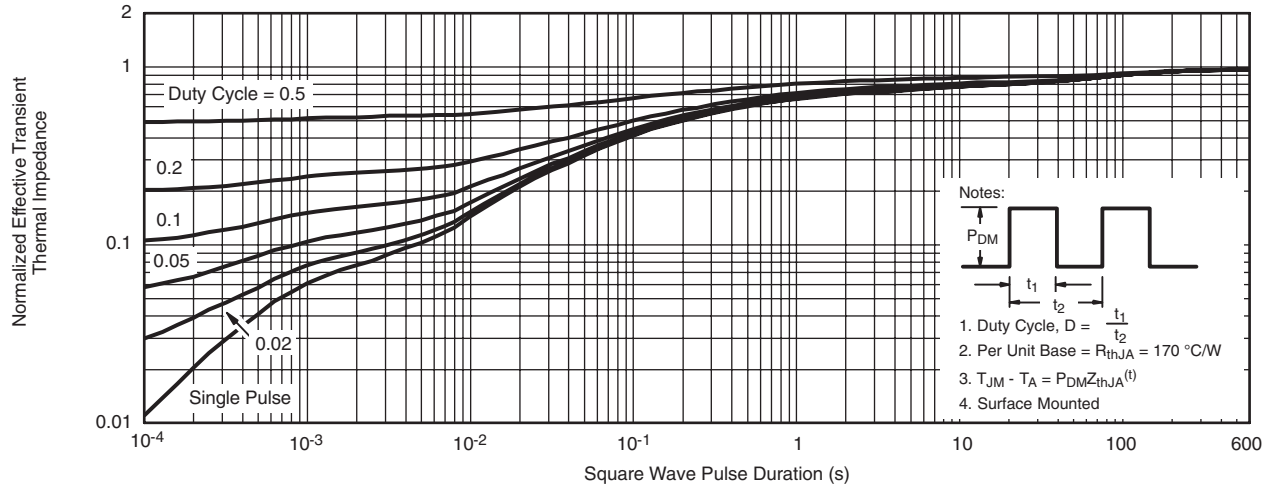

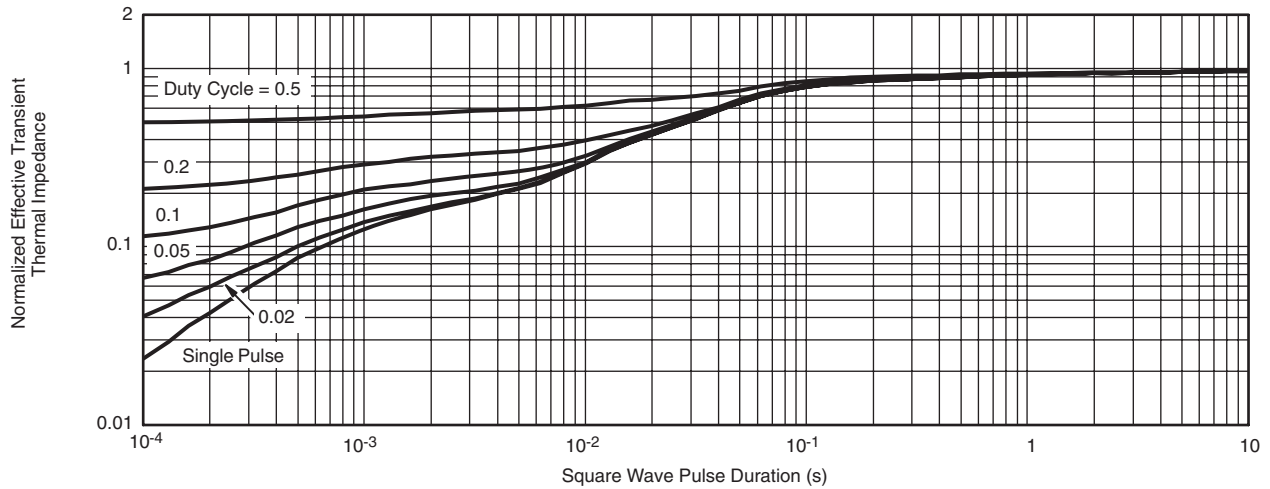
