

This dual 2-input positive-NOR gate is designed for 1.65-V to 5.5-V V_{CC} operation.





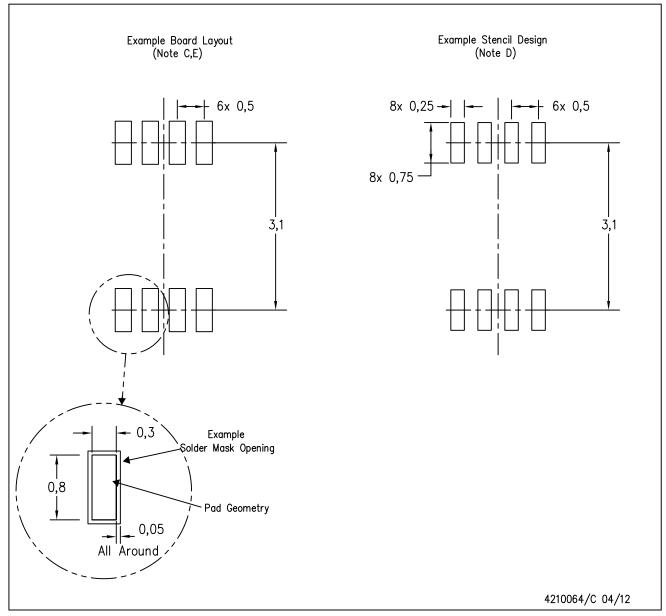

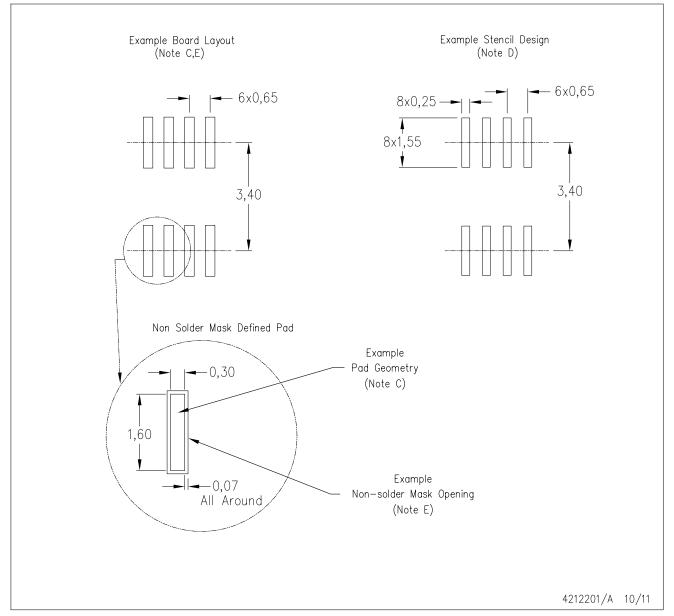
