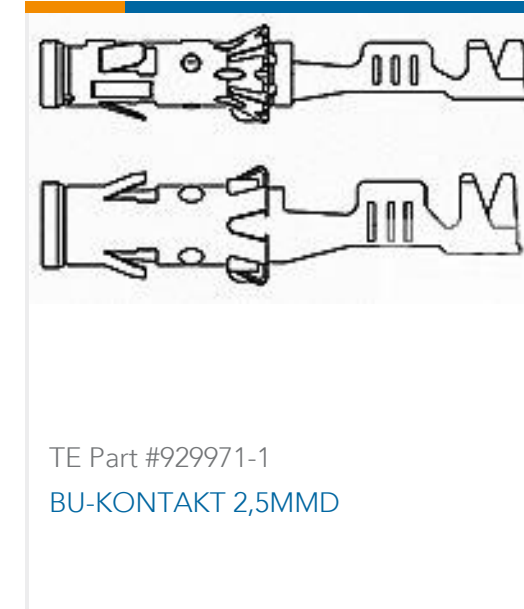
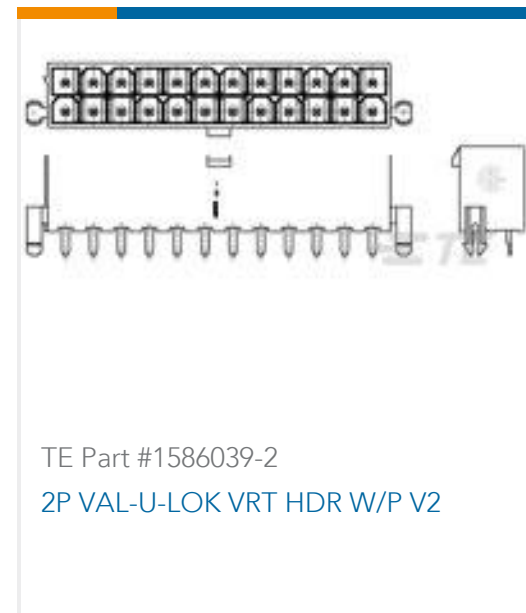


Crimp Terminal Housings(6)
