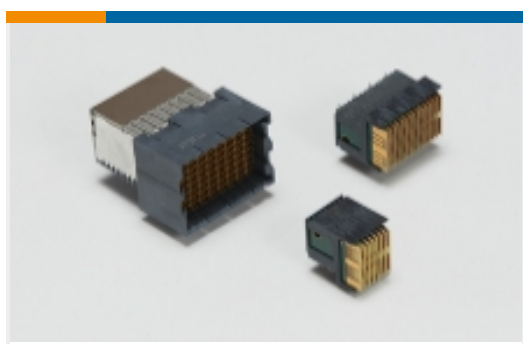




Board-to-Board Connector Contacts(2)



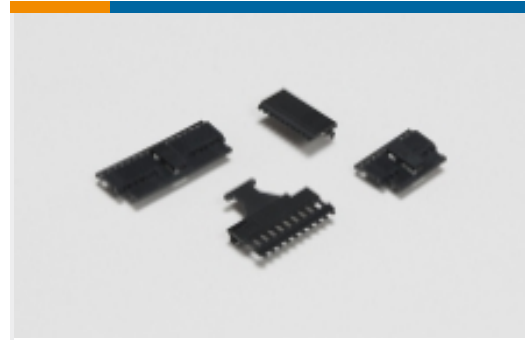
