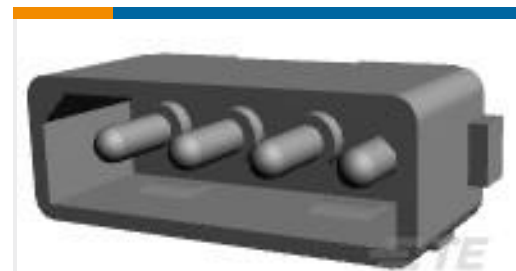
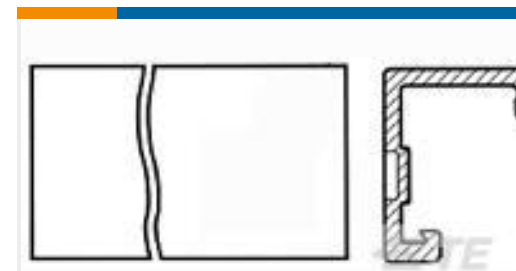
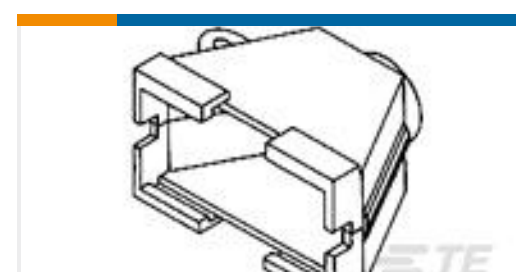


Standard Rectangular Connectors(7)
