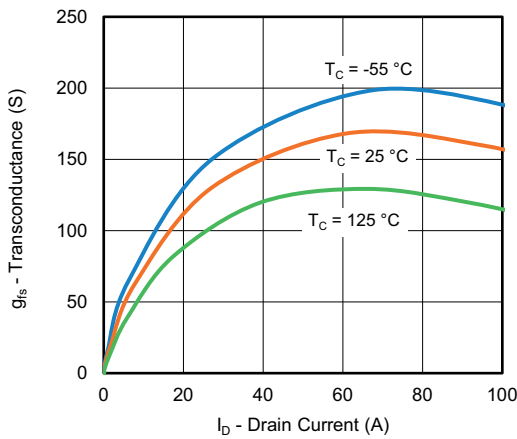

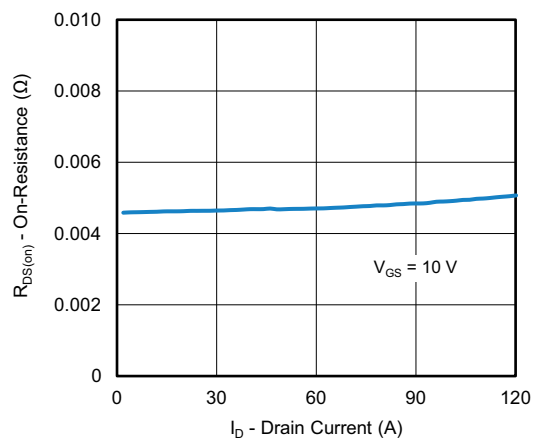

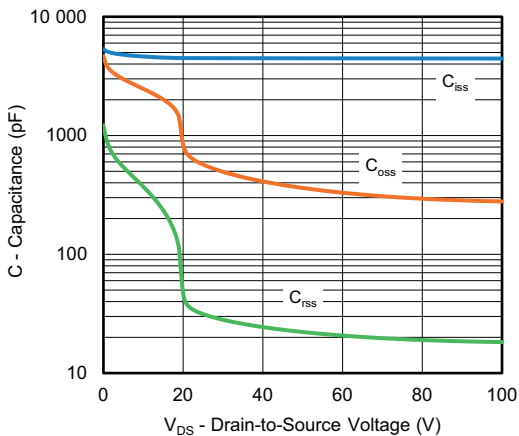
**Transfer Characteristics**



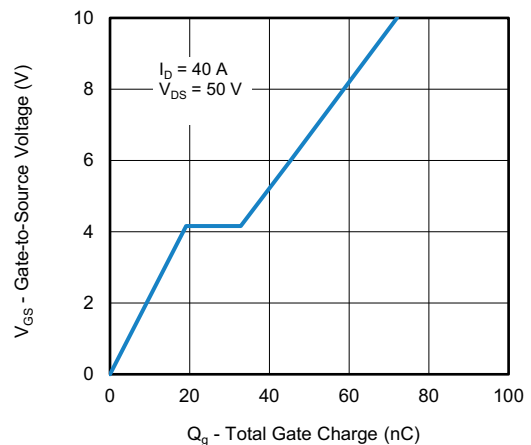

**On-Resistance vs. Drain Current**



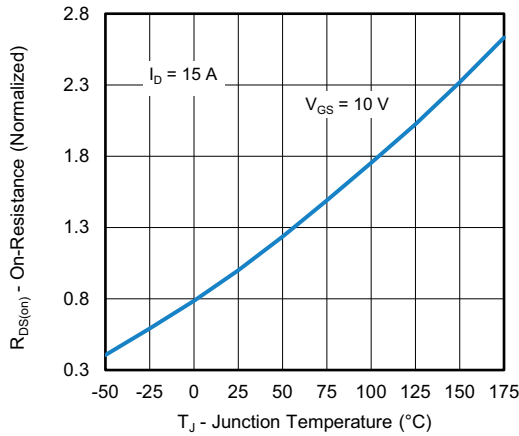

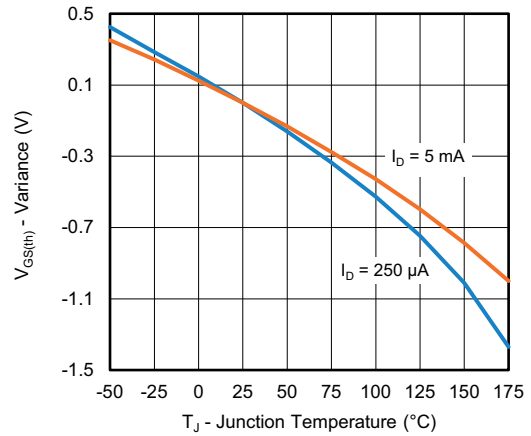

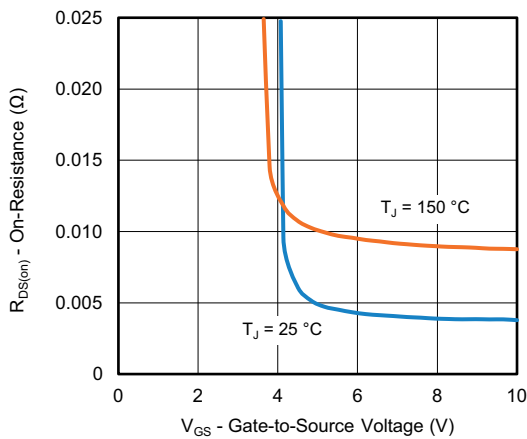

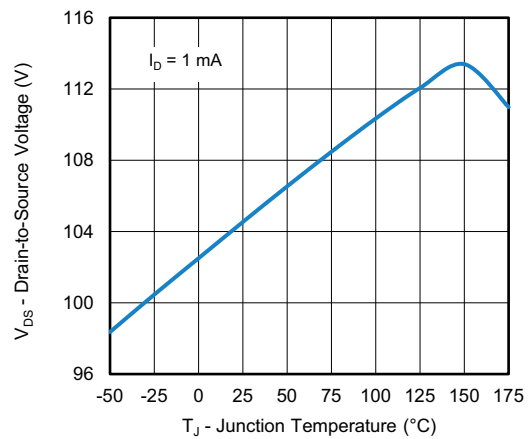
**On-Resistance vs. Junction Temperature**



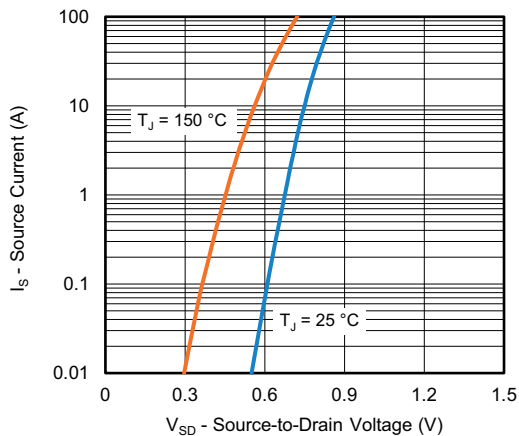

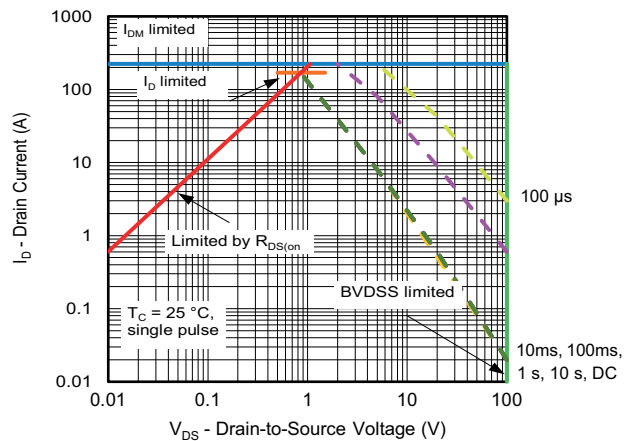
**On-Resistance vs. Gate-to Source Voltage**

**Source Drain Diode Forward Voltage**



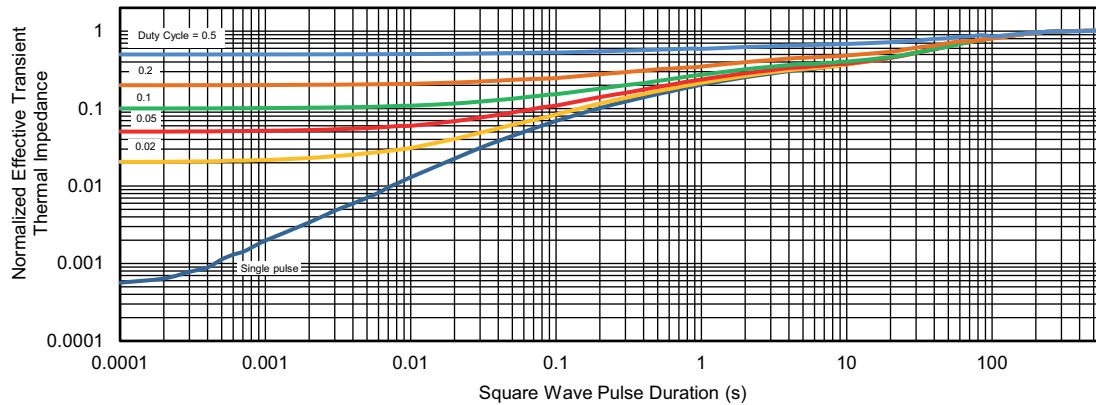

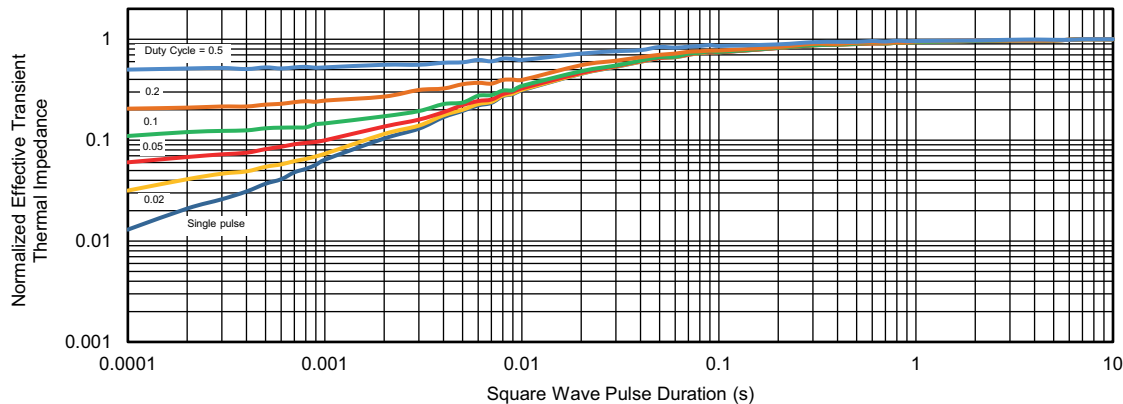

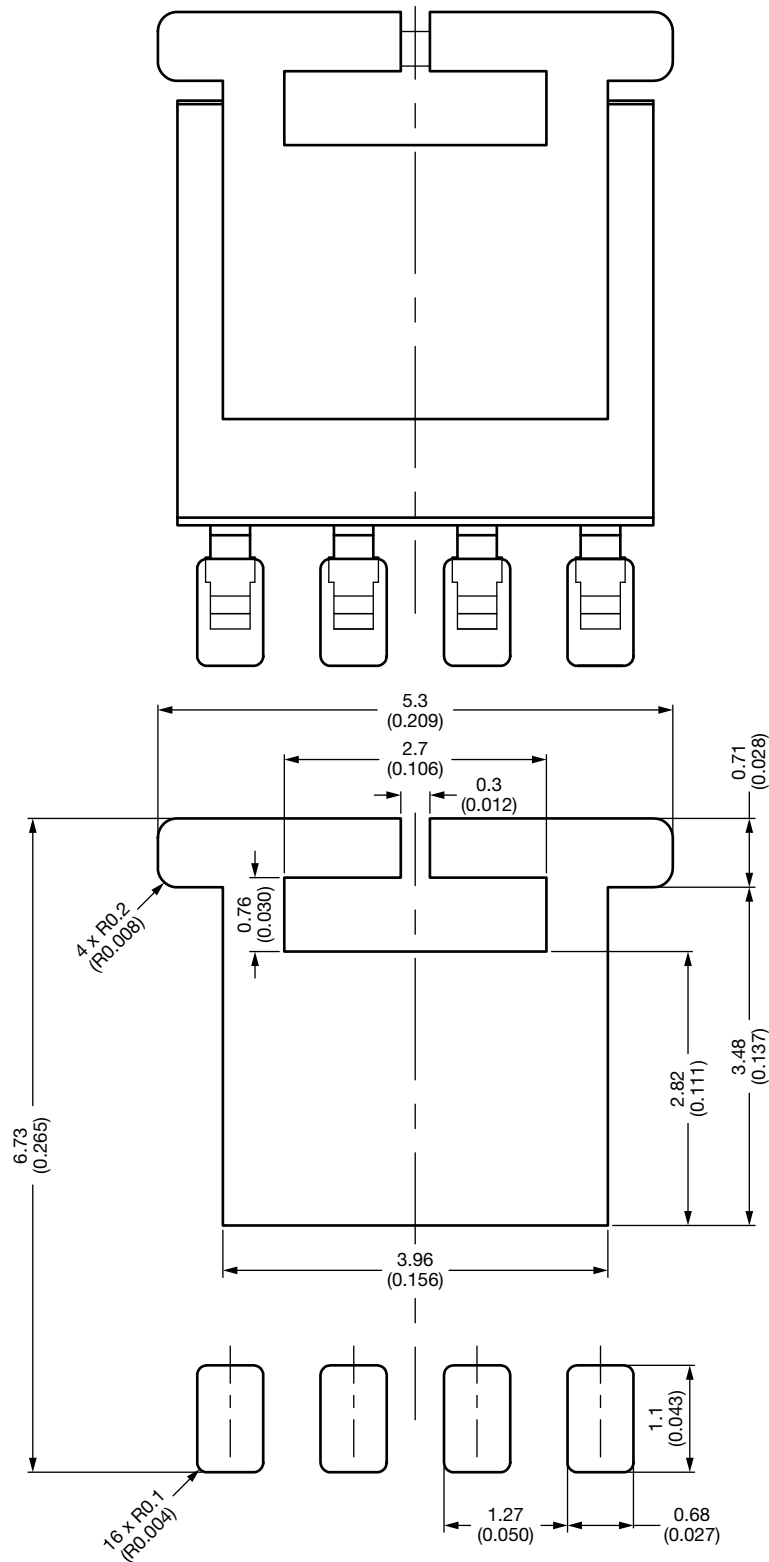
