The semiconductor in the SOT-227 package is isolated from the copper base plate, allowing for common heatsinks and compact assemblies to be built.




Fig. 1 - Typical Forward Voltage Drop Characteristics




Fig. 2 - Typical Values of Reverse Current




Fig. 3 - Maximum Allowable Case Temperature vs. Average Forward Current (Per Diode)




Fig. 4 - Average Power Loss vs. Average Forward Current




Fig. 5 - Junction Capacitance




Fig. 6 - Diode Reverse Recovery Time vs. dI_Fdt




Fig. 7 - Diode Reverse Recovery Current vs. dI_Fdt




Fig. 8 - Diode Reverse Recovery Charge vs. dl_Fdt





Fig. 9 - Maximum Thermal Impedance Junction to Case

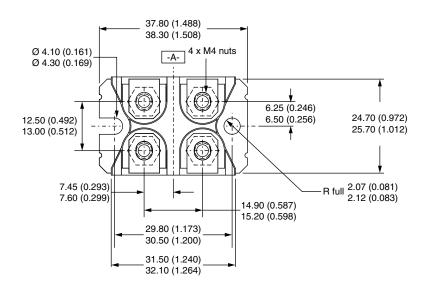

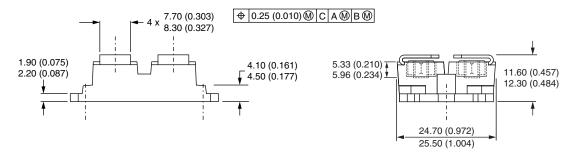
